

## **SlideShow Maker PRIVACY POLICY**

SlideShow Maker (“we” or “us” or “our”) respects the privacy of our users (“user” or “you”). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our mobile application SlideShow Maker (the “Application”). This Privacy Policy does not apply to the third-party online/mobile store from which you install the Application or make payments, including any in-game virtual items, which may also collect and use data about you. We are not responsible for any of the data collected by any such third party.

### **COLLECTION OF YOUR INFORMATION**

SlideShow Maker does not collect personally identifiable information from our users. We do not ask you to register to use the App or collect your name or e-mail address. All photos and videos remain on your device unless shared by you.

Depending on your use of the app, the following information may be collected:  
Derivative Data

Information our servers automatically collect when you access the Application, such as your native actions that are integral to the Application, including favorites and liking songs or video styles, as well as other interactions with the Application.

#### **Mobile Device Access**

To provide App functionality to you, we request access, solely with your permission, to certain features from your mobile device, including your mobile device’s camera, microphone, and storage. If you wish to change our access or permissions, you may do so in your device’s settings.

#### **Transaction Data**

If you choose to make a purchase in the App, information related to your purchase is collected directly by our platform partners. We do not collect or store any financial information. We receive information from our partners confirming the purchase to authorize your use of the app.

#### **Mobile Device Data**

To provide App functionality and track installations, a random identifier is attributed to your device. Should you uninstall the App, this number is no longer attributed to you.

## **USE OF YOUR INFORMATION**

Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the Application to:

### **Affiliates**

We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include our parent company and any subsidiaries, joint venture partners or other companies that we control or that are under common control with us.

### **Sale or Bankruptcy**

If we reorganize or sell all or a portion of our assets, undergo a merger, or are acquired by another entity, we may transfer your information to the successor entity. If we go out of business or enter bankruptcy, your information would be an asset transferred or acquired by a third party. You acknowledge that such transfers may occur and that the transferee may decline honor commitments we made in this Privacy Policy.

We are not responsible for the actions of third parties with whom you share personal or sensitive data, and we have no authority to manage or control third-party solicitations. If you no longer wish to receive correspondence, emails or other communications from third parties, you are responsible for contacting the third party directly.

### **App Analytics**
